

INVITATION FOR BIDS

Design, Supply, Erection, Testing & Commissioning of Power Transformers with associated switchgears on turnkey basis under Renovation, Extension, Rehabilitation & Augmentation of Grid Substations.

(Contract No.: PGCB/RRAGS/Phase-4/2020)

1. The Power Grid Company of Bangladesh Limited (PGCB), ('the Employer') invites sealed bids from eligible bidders for the **"Design, Supply, Erection, Testing & Commissioning of Power Transformers with associated switchgears on turnkey basis under Renovation, Extension, Rehabilitation & Augmentation of Grid Substations"** (hereinafter referred to as "the Works").
Tentative location of Transformers to be installed: Ghorashal 230/132/33 kV Substation, Barisal (Rupatoli) 132/33 kV SS, Sonargaon 132/33 kV SS, Tongi 132/33 kV SS, Chowmuhani 132/33 kV SS, Bhaluka 132/33 kV SS, Magura 132/33 kV SS.
2. **International Competitive Bidding (ICB)** will be conducted in accordance with Single-Stage: Two-Envelope bidding procedure and is open to all bidders from eligible source countries. PGCB will allocate necessary funds towards the cost of proposed works. The bidders are advised to inspect the bidding document by visiting the PGCB website <http://www.pgcb.gov.bd> or PGCB Head Office for further details from 10th January, 2020.
3. The Works under the contract shall be completed within 18 (eighteen) months from the Effective Date.
4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the **Company Secretary**, Power Grid Company of Bangladesh Ltd. For participating in this ICB, a complete set of bidding documents (which in English language) may be purchased by interested bidders from 10th January, 2020 upon submission of a written application to the **Company Secretary**, PGCB at the above address and upon payment of a nonrefundable fee of USD 300.00 (United States Dollar three hundred only) or Tk. 24,000.00 (Taka twenty four thousand) only in the form of Pay Order/Demand Draft in favor of the Power Grid Company of Bangladesh Limited. The Bidding Document may be sent through a courier for an additional fee of BD Tk. 1000.00 (local delivery) or USD 120.00 (International delivery) in the form of Pay Order/ Demand Draft in favor of Power Grid Company of Bangladesh Limited. PGCB shall not be responsible for any postal delay.
6. Bids must be delivered to the address mentioned above on or before 11:00 Hours Local Time on **20th February, 2020** and must be accompanied by a Bid Security in the amount and form as described in the bidding document.
7. The technical bids will be opened at 11:05 Hours Local Time on 20th February, 2020 at the head office of the Power Grid Company of Bangladesh Limited (PGCB), PGCB Head Office Building, Avenue-3, Jahurul Islam City, Aftabnagar, Badda, Dhaka-1212, Bangladesh in the presence of Bidders' representatives who choose to attend.
8. PGCB will not be responsible for any cost or expense incurred by bidders in connection with the preparation or delivery of bids including costs and expenses related to visit(s) to the site of installation of the works.
9. PGCB reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Bidders.
